ACADEMIC USE PURCHASE LICENSE AGREEMENT FOR THE modeFRONTIER SYSTEM

Subject to the terms and conditions contained in this Academic Use Software License Agreement (the "Agreement") ESTECO S.p.A., a company duly incorporated in Italy, with registered office in Trieste, Area Science Park, Padriciano 99 – Italy - ("Licensor") hereby grants to the Educational Institution or to any Affiliate to the Educational Institution (the "Licensee"), a non-exclusive license to use the proprietary modeFRONTIER SYSTEM, a multi-objective design optimization system (the "Software") and the materials (the "Licensed Materials"). Under the terms and conditions of the Agreement, Affiliate to the Educational Institution shall mean any faculty staff members, any administrative staff members and any official students which are currently enrolled within the Educational Institution and are able to provide evidence of the enrollment status. Licensor and Licensee also are referred hereto individually as a "Party" and jointly as the "Parties".

1.Software

- a. Licensor is the owner of the software modeFRONTIER, a multi-objective design optimization system allowing users to improve their business decision making process. The Software is more specifically described in the file "EXTENSIVE_SW_DESCRIPTION.TXT", a copy of which can be found either in the installation directory or on the installation media.
- b. The installation package of the Software includes: one (1) copy of the Software in machine-readable object code form and one (1) copy of the Licensed Materials containing detailed specifications for the operation and use of the Software. The installation package of the Software shall be provided by an independent distributor authorized by Licensor (the "Distributor"), or directly by the Licensor, as the case may be.

2.License

a.License. Subject to the terms and conditions of this Agreement, Licensor grants to Licensee a non-transferable and non-exclusive license to install and to use the Software for non- commercial or academic purposes for the term of this Agreement, in accordance with the uses authorized at paragraph d. of this section.

b.Authorization Key. In connection with the license(s) granted herein, Licensor shall provide to Licensee with an individual user license file (the "Academic Key") which shall be valid solely at the installation address and on a single machine or multiple machines, as the case may be, for which the Licensor has issued the Academic Key. Each Academic Key purchased under the name "Professor" shall allow installation and use of the Software only within the Licensee's computing network and within the territory of the country where the Licensee's server is located (the "Country Account License") and Licensor shall issue an Academic Key valid solely in the territory indicated by Licensee.

It remains understood that any Academic Key purchased under the name "PhD" and/or "Student" shall instead allow use of the Software only node-locked to the corresponding host ID and host name.

Title to each Academic Key will remain with Licensor and Licensor may reclaim any Academic Keys upon termination of this Agreement as provided under Section 9 a. of this Agreement.

c.Server Change. Upon Licensee's written request made to Licensor or to Distributor, Licensees holding a license may obtain only one change of the Educational Institution's server allowing access to the Software in the event of server dismissal, obsolete, broken or reallocated to other services. It remains understood that any Licensee undertakes to cancel the license file relating to the Academic Key and replace it with the new Academic Key authorized to run at the new installation machines identified in writing by Licensee. Server change can be requested and obtained only once by each Licensee and upon evidence that the Educational Institution's server is dismissed, obsolete, broken or reallocated to other services. Partial server changes (for one license only or for one add-on)are not allowed.

d.License Restrictions. This license is intended solely for academic use. For the purpose of this Agreement, "academic use" means use of the Software limited to any Affiliate to the Educational Institution authorized to use the Software in furtherance of educational activities, including teaching and non-profit academic and non-commercial activities.

Licensee shall NOT take any or all of the following actions:

i.use the Software for any commercial applications or for any services to others under any tradenames, trademarks or service marks, other than that of Licensee;

ii.make the Software accessible by or to third parties in an automated way through network connections as an application service provider;

iii.sell, license, sub-license, lease, assign or otherwise transfer (whether by sale, exchange, gift, operation of law or otherwise) to third parties the Software, any copy thereof, in whole or in part, without Licensor's prior written consent;

iv.modify or change the Software;

v.decompile, disassemble or otherwise reverse engineer the Software.

vi.use the Academic Key granted for a server allowing access to the Software upon a server change. In such a case, Licensee undertakes to use only the new Academic Key authorized to run at the new installation address.

In this regard, Licensee undertakes, under the terms and to the effects of section 1381 of the Italian Civil Code, that any third parties authorized to use the Software herein shall comply with the obligations contained in this paragraph.

e.License Term. The term of this license is 12 (twelve) months, unless terminated earlier as provided in Section 9.a of this Agreement, commencing upon Licensee's acceptance of this Agreement by



selecting the button "I AGREE" appearing at the bottom of this screen or by signing the relevant document in any legal and binding form.

It remains understood that the general terms and conditions contained herein shall enter into force upon the acceptance in writing by Licensee of the applicable Software license fees.

3.Use

a. Proper Conditions of Use. Licensee shall be exclusively responsible for the supervision, management and control of the use of the Software, including without limitation:

i.assuring proper machine configurations, audit controls and operating methods;

ii.establishing adequate backup plans, based on alternative procedures and access to qualified programming personnel;

iii.implementing sufficient recovery procedures and checkpoints to satisfy its requirements for security and accuracy of input, as well as, system restart and recovery in the event of a malfunction.

In this regard, Licensee undertakes, under the terms and to the effects of section 1381 of the Italian Civil Code, that any third parties authorized to use the Software herein shall comply with the obligations contained in this paragraph.

b.Copying. Licensee may not copy or otherwise reproduce the Software, or any part thereof (except such copying, strictly limited in number, as is essential for system backup, testing, maintenance or recovery purposes as provided by applicable law). Licensee may reproduce the Licensed Materials solely for its own internal use, provided that all titles, trademarks, trade names, copyright notices, and other proprietary notices of Licensor are retained. In this regard, Licensee undertakes, under the terms and to the effects of section 1381 of the Italian Civil Code, that any third parties authorized to use the Software herein shall comply with the obligations contained in this paragraph.

4.License Fees and Payments

a.For the license(s) granted in this Agreement, Licensee shall pay, indirectly through the Distributor or directly to the Licensor, as the case may be, the license fees relating to the Country Account License, on the basis of the price list (the "Price List") agreed upon inwriting between, on one side, the Distributor or the Licensor and, on the other side, the Licensee, as the case may be.

b.In the event the Price List is agreed upon between the Distributor and the Licensee, the Distributor shall be solely responsible for collection of all fees and charges set forth on the Price List. The Distributor shall keep complete and accurate records of all the purchase orders and invoices issued, respectively, by Licensee and Distributor relating to the Software license fees. Licensor shall have the right to inspect and audit such records for the purpose of determining the accuracy thereof.



c. Notwithstanding anything to the contrary contained in this Agreement or in the Price List, Licensee acknowledges that Distributor or Licensor, in its discretion, may change the license fees for additional copies of the Software, the Licensed Materials or the Academic Key, upon thirty (30) days prior written notice to Licensee.

d.Licensee shall be entitled to grant Software licenses free of charge to certain individual faculty members and/or official students of the Educational Institution upon signature of a letter of intent whereby any sponsored licensees undertake to comply with additional obligations on a personal basis.

5.Confidential Information

Licensee shall not, either directly or indirectly, disclose to third parties or use any information which are not in the public domain, in any form, whether obtained prior to or after the execution of this Agreement and for a period of one (1) year following its termination, relating to the Software, the Licensed Materials, Licensor and any information concerning the technical data, contacts, know how, software applications, license files, correspondence, names, addresses, and any other written or oral information which may be used in relation to the Agreement (the "Confidential Information"); it remains understood that information shall not be considered Confidential Information for the purposes of any section of this Agreement in the event disclosure shall be necessary:

- (i) in order to execute this Agreement and
- (ii) in order to be in compliance with applicable law, regulation, court order or other legal process, provided Licensee has given Licensor prior written notice of and, to the extent reasonably possible, an opportunity to contest such required disclosure. Licensee shall implement reasonable procedures to prohibit the disclosure, unauthorized duplication, misuse or removal of the Confidential Information.

6.Title

Licensee agrees that Licensor owns all copyright, trade secret, patent, trademark and other proprietary rights in and to the Software, including all modifications thereto and to the databases created by Licensor. All rights not expressly granted to Licenses under this Agreement are reserved by Licensor.

7. Warranties

a.Licensor warrants that it has clear title to the Software. Licensor further warrants that the Software will conform, as to all substantial operational features, to Licensor's current published specifications when installed.

b.THE ABOVE IS A LIMITED WARRANTY AND IT IS THE ONLY WARRANTY MADE BYLICENSOR. LICENSOR MAKES AND LICENSEE RECEIVES NO WARRANTY, EXPRESS ORIMPLIED, AND THERE



ARE EXPRESSLY EXCLUDED ALL WARRANTIES OFMERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THE STATED EXPRESSWARRANTY IS IN LIEU OF ALL LIABILITIES OR OBLIGATIONS OF LICENSOR FORDAMAGES ARISING OUT OF OR IN CONNECTION WITH THE DELIVERY, USE, ORPERFORMANCE OF THE SOFTWARE AND OF THE LICENSED MATERIALS.

c.If any modifications are made to the Software at any time by Licensee, this warranty shall immediately be terminated. Educational Institution agrees that Licensor's liability arising out of contract, negligence, strict liability in tort or warranty shall not exceed any amounts payable by Licensee for the Software and the Licensed Materials.

8.Termination

a.Licensor shall have the right to terminate this Agreement by giving written notice to the Licensee upon the occurrence of any of the following events:

i.any use of the Software by the Licensee in any manner other than as authorized in this Agreement;

ii.any copy or otherwise reproduction of the Software by the Licensee other than as provided by applicable law;

iii.in the event of breach of the obligation to pay the license fees due by the Licensee as provided herein.

b.In the event of termination of this Agreement by reason of Licensee's failure to comply with any of the obligations provided under section 8.a above, Licensor shall have the right, at any time, to terminate the license(s) and take immediate possession of the Software and the Licensed Materials and all copies wherever located, including the Academic Key. Termination under this paragraph shall not relieve Licensee of its obligations regarding confidentiality of the Software. Within five (5) days after termination of the Agreement, Licensee will return to Licensor the Software in the form provided by Licensor or as modified by the Licensee and upon request by Licensor, will cancel the license file relating to the Software and certify in writing that they have been duly cancelled.

c.Licensee may terminate this Agreement at any time provided that payment in full has been made to the Distributor or to Licensor, as the case may be, and Licensee returns the original and all copies of the Software and of the Licensed Materials to Licensor.

9.Non-Competition

During the term of this Agreement and for a period of one (1) year following the termination of this Agreement, Licensee agrees not to engage, and under the terms and to the effects of section 1381 of the Italian Civil Code that any third parties authorized to use the Software shall not engage, in the development, marketing, or distribution, either directly or indirectly, of any computer programs

related to design optimization with functionalities similar to, or competitive with, the Software or substantial portion of the Software.

10.Disclosure obligations

In relation to any written publications, oral speeches, graduation papers and any other presentations whereby the Software was used to accomplish any results and/or developments displayed in any academic, post-graduate, research study and/management activities carried out by Licensee, Licensee undertakes to properly attribute the name of the name of the Software and the name of the company ESTECO S.p.A. Furthermore, Licensee undertakes to share with Licensor any academic, post-graduate thesis, any research papers and any study report whereby the methodologies used and the results obtained are described in detail. In particular, such document must describe the way the Software was used during the research activities, including the information regarding the methodologies applied. In the event that Licensor believes there are inaccuracies therein, Licensee shall make best efforts to make such corrections. With reference to the methodologies described above, Licensee authorizes Licensor to reproduce or reference such writings in part or in whole, solely for promotional purposes. It remains understood that Licensor shall inform in writing Licensee before carrying out any of such activities. In this regard, Licensee undertakes, under the terms and to the effects of section 1381 of the Italian Civil Code, that any third parties authorized to use the Software herein shall comply with the obligations contained in this paragraph.

11. General Provisions

a. Assignability. This Agreement and all rights and obligations hereunder shall not be assignable by Licensee except with the prior written consent of Licensor.

b.Liability. No action or claim relating to this Agreement or the Software may be instituted more than one (1) year after the event giving rise to such action or claim.

c.Indemnification. Licensor shall indemnify and hold Licensee harmless from and against any claim of infringement of any patent or copyright based upon the Software, provided Licensee gives Licensor prompt notice of and the opportunity to defend any such claim. Licensor shall have the right to settle such claim or, at Licensor's option, provide Licensee with:

- (i) apaid-up license;
- (ii) substitute, functionally equivalent software; or
- (iii) a refund of a pro rata portion of the license fee paid by Licensee, associated with the remaining term of the Agreement, from the date the infringement claim is filed with a court of competent jurisdiction and until the expiration or termination of this Agreement.

d.Security Mechanisms. Licensor reserves the right to embed a software security mechanism within the Software to detect the installation or use of illegal copies of the Software and collect and transmit data only about those illegal copies. Data collected will not include any customer data created with the Software. By using the Software, License consent to such detection and collection of data, as well as its transmission and use ifan illegal copy is detected.

e.Entire Agreement; Amendment. Licensee acknowledges that it has read this Agreement, understands it and agrees to be bound by all terms and conditions hereof. All subsequent modifications, amendments, and waivers to this Agreement must be by written instrument, executed by authorized representatives of the parties hereto.

f.Survival. The rights and obligations contained in Sections 4, 5, 6, 7, 8 b., 9, 10, 11b., 11d., 11f., 11.g and 11.h shall survive any termination of this Agreement.

g.Choice of Law and Venue. This Agreement shall be governed by the laws of Italy. The parties hereby agree to submit to the exclusive jurisdiction of the competent courts sitting in Trieste, Italy, with respect to any and all unresolved disputes arising under this Agreement and the Software.

h.No Russia. Licensee undertakes not to sell, export or re-export, directly or indirectly, to the Russian Federation any rights relating to the Software and the Licensed Materials distributed under this Agreement that fall under the scope of art. 12g. of the Council Regulation EU 833/2014 and subsequent amendments.

i. Severability. In the event that any provision under this Agreement shall be deemed illegal or otherwise unenforceable by any applicable statute or rule of law, such provision shall be omitted and the entire Agreement shall not fail on account thereof and the remainder of the Agreement shall continue in full force and effect.

j. Third Party Components. Licensor reserves the right to use and/or provide within the Software third party software, libraries, executables or other components, either commercial or open source, in accordance with applicable law.

k.Notices. All notices and other communications required under this Agreement shall be inwriting and shall be sent either by personal delivery, recognized courier service or first class registered mail. All notices shall be deemed to have been received the same day, when personally delivered, or three days after posting, when sent by any of the other methods listed above.
